Register of Voting Affiliates of the League

Register of Voting Affiliates – Current to 30th September 2018

A Voting Affiliate, means a Member of the League, which has the right to appoint a Delegate to attend, debate and vote on behalf of the Voting Affiliate at General Meetings of the League in accordance with Rule 7 of the Constitution of the League.

Voting Affiliate includes State League Clubs, the State League Standing Committee, the Junior League Standing Committee, the Country League Standing Committee, the Women’s League Standing Committee, the Sydney Winter League Standing Committee, the Umpires Association, the Scorers Association, the Minor League Standing Committee and Regional Associations.

A Regional Association means an organisation that conducts baseball competition(s) in a particular geographic region and is recognised by the League as a Voting Affiliate by the League. Competition means a series of games of Baseball played over a period of not less than eight (8) weeks and comprising a minimum of six (6) teams.

Voting at General Meetings

Each Voting Affiliate in attendance shall be entitled to 1 vote at General Meetings, except that:

- a) Each Voting Affiliate shall be entitled to an additional vote where it has more than 500 registered Players; and
- (b) Each Voting Affiliate shall be entitled to a second additional vote where it has more than 1,000 registered Players.

No Voting Affiliate shall be entitled to more than 3 votes on any motion, and where a Voting Affiliate is entitled to exercise multiple votes each vote must be directed in the same manner.

Incorporation

Amongst other criteria is the requirement for voting affiliates to be incorporated within New South Wales, excepting Standing Committees.
