NOMINATION FOR APPOINTMENT TO THE AUDIT COMMITTEE



Supporting Notes

"Member" means a member for the time being of the League under **Part III** of the Constitution.

Category of Members

The Members of the League shall consist of:

- a) Voting Affiliates, who subject to the Constitution, shall be represented by their Delegate who shall have the right to attend, debate and vote at General Meetings for and on behalf of the Voting Affiliate;
- b) Affiliated Clubs, who subject to this Constitution, may attend and debate at General Meetings, but have no right to vote at General Meetings;
- c) Individual Members, who subject to the Constitution, may attend and debate at General Meetings, but have no right to vote at General Meetings;
- d) Life Members, who subject to the Constitution, may attend and debate at General Meetings, but have no right to vote at General Meetings;
- e) Such new categories of Members, created in accordance with **Rule 7.2**.

Voting Affiliate includes Major League Clubs, the Major League Standing Committee, the Junior League Standing Committee, the Country League Standing Committee, the Women's League Standing Committee, the Sydney Winter League Standing Committee, the Umpires Association, the Scorers Association, the Associations Standing Committee and Regional Associations.

A **Regional Association** means an organisation that conducts baseball competition(s) in a particular geographic region and is recognised by the League as a Voting Affiliate by the League. Competition means a series of games of Baseball played over a period of not less than eight (8) weeks and comprising a minimum of six (6) teams.
